- I. Welcome and Introductions (5 min)
- II. Update on student equity plan - Claudia and Anna (5 min)
 - a. Equity plan guides campus efforts the next 3 years on disproportionately impacted students
 - b. First time to college only student data
 - c. Provide feedback – need to capture what we are currently doing to support DI groups; comment on any areas where you see things missing from the strategies.

Committee voted to change meeting times and location

Changes to charge - “Membership”

V. Diversity Committee funding (20 min)

Committee receives \$10,000 from the district to do DEIAA work; the committee has received these funds for the past 5 years

- a. Work on a process for distributing funds
 - Discussed the possibility of exploring spending funds on one or two big events or distributing smaller amounts of funding to different constituencies
 - Discussed putting a certain amount of funds aside specifically for student organizations who are doing DEIAA work
 - Everyone will be looking into other campuses’ processes and will bring it back the next meeting
- b. Create form – next meeting we will work on a form to share with the campus
- c. Create rubric – will look at rubrics from other campuses
- d. Create timeline – will have a process ready to disseminate to the campus before the end of the semester; Goal is to have something in place two meetings from now
